Note:

- 1. Composite Fee does not include Transport, Uniform, Textbooks/Notebooks, Stationery, individual learning sport like Special Sports Equipment (if applicable).
- 2. First installment has to be paid along with the registration fee and that is non-refundable.
- 3. Optional Fee such as Examination Fee (NCO, IMO, NSO, Asset, any govt. exams like CBSE boards etc.), Trips/Excursions and other activities (like cultural events, tours, class photos, etc.) will be charged as per actual.

- 4. Parents kindly note that if there is any Fee Regulation by the Fee Committee (DFRC) set up by Govt./CBSE, then in this case student is not entitled to avail offer on prescribed Composite Fee. Any govt. levy on school will be charged extra.
- 5. The school reserves the right to revise/amend the Fee Structure from time to time, as per guidelines of DFRC.
- **6.** Fees may be paid in the school A/C office from 8:00am till 2:00pm on all working days or otherwise through online payment.
- 7. On depositing fee for entire academic year at the time of admission get discount of one month composite fee i.e. instead of paying fee for 12 months pay fee for 11 months.
- **8.** Late Fee Payment Penalty If the fee is not paid by the stipulated date, a late fee of Rs 10/- per day (including holidays) will be charged.
- 9. Non-Payment of Fee for a further of 30 days after the pay by date shall result in Cancellation of Admission. To reinstate the admission, a penalty of Rs. 3000/- will be charged in addition to the Late Fee Payment Penalty.
- 10. Issues related to any fee withdrawal are subject to terms and conditions of School's Fee Withdrawal Policy.
